Sponsorship Opportunities

Sponsor Membership:

£200/year one person, £300/year couple

If Members wish to be a Sponsor Member for one year, there is no pressure to continue the arrangement for subsequent years. The choice is yours from year to year. Any normal membership fees already paid can count towards the Sponsor Membership, hence if you have paid, say, £15 in January and then become a Sponsor Member in April, you only need to pay £200-£15=£185. Any extra top up paid with the normal membership can also count towards the Sponsor Membership.

Benefits:

- Reserved seats of your choice for all concerts including Farnham concerts;
- 2 free tickets for guests for either Friday or Saturday of Festival (designed for guests who do not come to TBS concerts regularly);
- 2 free tickets for guests for any one Farnham concert (designed for guests who do not come to TBS concerts regularly);
- Acknowledgement in Festival Programme as a sponsor (you can opt out if you wish);
- Invitations to social gatherings with musicians and committee - at present this means the parties after the Carol services and after one Festival evening - usually Saturday, and Festival Sunday lunch if/when we are able to organise it;
- Attendance at rehearsals whenever possible;
- We are happy to consider any additional benefits suggested by members.

Sponsorship of an individual concert already in the programme:

Any sum over £50 (one or two people)

Benefits:

- Reserved seats of your choice at concert concerned;
- Acknowledgement in Concert Programme of your sponsorship (you can opt out if you wish);
- Option to dedicate the sponsorship, eg celebration of birthday, anniversary or memory of someone special;
- If the sponsorship gift and the total of your membership and other gifts in the year qualify you for Sponsor Membership then you will have all the benefits of Sponsor Membership.

Sponsorship of an individual concert that you propose:

Any sum over £400 (one or two people)

Benefits:

- Possibility to propose the performer and/or programme - subject to reasonable agreement with the Music Director and Committee on the performer and music. The nominal budget for the concert (musician fees plus venue) would then be your sponsorship plus £400 from TBS funds;
- **Sponsor Membership for the year for one or two people-** see above;

- Acknowledgement in Concert Programme of your sponsorship (you can opt out if you wish);
- Option to dedicate the sponsorship, eg celebration of birthday, anniversary or memory - this could include saying a few words to the audience at the start of the concert.

Special sponsorship concerts

In future, if we want to have a concert by well-known musicians who are out of our normal price range, we may ask for members to contribute to the amount by which the costs exceed our normal expenditure.

Gift Aid

All sponsorship can be Gift Aided, adding 25% tax reclaim to the sum handed to TBS. Sponsors who are higher rate tax payers gain additional tax relief. The sums above are net of Gift Aid, ie they are the amounts given to TBS.
